

Guide to the Medical Subsidy for Children

● Eligibility

1. Children up to the 3rd year of junior high school
(until the first March 31 after they turn 15 and up to the end of March for those born on April 1)
2. Those who have an address in Tsu City
3. Those who are enrolled in health insurance
4. Those who are not protected by the Public Assistance Act

* Note that children who satisfy the above requirements may not be eligible for the subsidy depending on the income of their parents or guardian.

● Items required for application

1. Personal seal (rubber stamp seals not accepted)
2. Medical insurance card (printed with the child's name)
3. Passbook (in the case of Japan Post Bank, a passbook that shows the branch name and account number for bank transfers, and not the conventional passbook number)
4. Document that can be used to verify the child's "My Number" (My Number card, personal number notification card, or residence certificate that shows the individual number)
5. Consent form [For within the city For outside the city (FY) Consenter:]

● Delayed applications

If you do not apply within 2 months from the day your child is born or 1 month from the day you have moved in to Tsu City (in the case of incoming residents), the date you are deemed to qualify for the Medical Subsidy for Children will be the first day of the month in which you submitted your application.

Guide to the Medical Subsidy for Expectant and Nursing Mothers

● Eligibility

1. Expectant mothers who are more than 5 months into their pregnancy and nursing mothers
(until the end of the month after the month in which they had a child)
2. Those who have an address in Tsu City
3. Those who are enrolled in health insurance
4. Those who are not protected by the Public Assistance Act

* Note that those who satisfy the above requirements may not be eligible for the subsidy depending on their income or the income of their spouse, etc.

● Items required for application

1. Doctor's certificate showing that you are in your fifth month of pregnancy (a document fee may be charged at some hospitals)
Please obtain a doctor's certificate upon verifying your eligibility status at the Welfare and Medical Expenses Counter.
2. Personal seal (rubber stamp seals not accepted)
3. Medical insurance card (printed with your name)
4. Passbook
5. Document that can be used to verify your My Number
6. Consent form [For within the city For outside the city (FY) Consenter:]

● Delayed applications

If you do not apply within 2 months from the day you enter your fifth month of pregnancy or within 1 month from the day you have moved in to Tsu City (in the case of incoming residents), the date you are deemed to qualify for the Medical Subsidy for Expectant and Nursing Mothers will be the first day of the month in which you submitted your application.

Guide to the Medical Subsidy for Disabled Persons and Disabled Persons Over 65

● Eligibility

1. Residents who meet the following disability requirements:
 - Those who have a physical disability certificate (grades 1 – 3)
 - Those who have a rehabilitation certificate (grades A, B1 or document showing a diagnosis for an IQ score of 50 or lower)
 - Those who have a mental disability certificate (grades 1 – 2)
 2. Those who have an address in Tsu City
 3. Those who are enrolled in health insurance
 4. Those who are not protected by the Public Assistance Act
- * Note that people who satisfy the above requirements may not be eligible for the subsidy depending on their income or the income of their supporter under duty, etc.

● Items required for application

1. Physical disability certificate, rehabilitation certificate, or mental disability certificate
2. Personal seal (rubber stamp seals not accepted)
3. Medical insurance card (printed with your name)
4. Passbook (in the case of Japan Post Bank, a passbook that shows the branch name and account number for bank transfers, and not the conventional passbook number)
5. Document that can be used to verify your “My Number” (My Number card, personal number notification card or residence certificate that shows the individual number)
6. Consent form [For within the city For outside the city (FY) Consenter:]

● Delayed applications

If you do not apply within 1 month from the date of the notification regarding the issuance of a certificate or 1 month from the date on which you moved in to Tsu City (in the case of incoming residents), the date you are deemed to qualify for the Medical Subsidy for Disabled Persons and Disabled Persons Over 65 will be the first day of the month in which you submitted the application.

Guide to the Medical Subsidy for Single-parent Households

● Eligibility

1. Single parents raising a child under the age of 18 and their children
 2. Children under the age of 18 who have no parents
 3. Single people who have custody of a child under the age of 18 who have no parents
 4. Those who have an address in Tsu City
 5. Those who are enrolled in health insurance
 6. Those who are not protected by the Public Assistance Act
- * Note that people who satisfy the above requirements may not be eligible for the subsidy depending on their income or the income of their supporter under duty, etc.

● Items required for application

1. Personal seal (rubber stamp seals not accepted)
2. Medical insurance card (printed with your name)
3. Certificate of all records in your family register (full family register)
4. Passbook (in the case of Japan Post Bank, a passbook that shows the branch name and account number for bank transfers, and not the conventional passbook number)
5. Document that can be used to verify your “My Number” (My Number card, personal number notification card or residence certificate that shows the individual number)
6. Consent form [For within the city For outside the city (FY) Consenter:]

● Delayed applications

If you do not apply within 2 months from the date on which the requirement has occurred or 1 month from the date on which you moved in to Tsu City (in the case of incoming residents), the date you are deemed to qualify for the Medical Subsidy for Single-parent Households will be the first day of the month in which you submitted the application.
